

THE CUSTOMS TARIFF ACT

**Regulations made by the Minister under section 15
of the Customs Tariff Act**

1. These regulations may be cited as the Customs Tariff (Amendment of Schedule) (No. 2) Regulations 2016.
2. In these regulations –
"Act" means the Customs Tariff Act;
"item" includes the entries corresponding to the item.
3. The First Schedule to the Act is amended, in Part I –
 - (a) by deleting the items specified in Part I of the Schedule to these regulations; and
 - (b) by inserting, in the appropriate numerical order, the items specified in Part II of the Schedule to these regulations.
4. These regulations shall come into operation on 30 July 2016.
