- (i) I have been exempted from the payment of the Customs duty & VAT under the provisions of the Customs Tariff Act and Value Added Tax Act respectively;
- (ii) Any breach to this exemption shall be dealt with in accordance with the provisions of the Customs laws, the Investment Promotion (Mauritian Diaspora Scheme) Regulations 2015 and the Investment Promotion Act;
- (iii) In case I shall be deregistered under the Scheme, I undertake to comply with the provisions of subsection 9(6) of the Investment Promotion (Mauritian Diaspora Scheme) Regulations 2015.

I hereby undertake, for a period of 4 years, to **forthwith notify** the Director-General, MRA of the fact that in case I intend to sell, transfer, use or apply the household and personal effects, other than in respect of which the exemption was granted or in case I am not able to comply with any of the conditions regarding this exemption. In this regard, I also undertake to pay duty and taxes as per the provisions of Section 5 of the Customs Tariff Act;
