5. Business Registration Number where applicable
6. Statement of Emoluments and Tax Deduction for self / dependent(s)
7. Statement of Amount Paid and Tax Deduction in respect of income subject to Tax Deduction at Source (TDS)
8. Profit & Loss Account where a taxpayer derives income from Trade, Business or Profession
9. Certificate in respect of :
 - i) Share of income received from Société/Succession, if any
 - ii) Medical insurance premium or contribution to approved Provident Fund, if any
 - iii) Interest paid on Secured Housing Loan, if any
10. Relevant Information in respect of :
 - i) Dividends and Interest received from self / dependent(s), if any
 - ii) Dependent child pursuing Undergraduate Course
11. Receipts in respect of CPS paid for the CPS Quarter ended 31st March 2015
