The **VAT Lucky Draw Scheme (VLDS)** was promoted by the Mauritius Revenue Authority (MRA) in 2014 as an incentive to encourage the local population to claim a receipt for every transaction and for the VAT registered persons to issue a VAT invoice for every sales/ transactions.

The VLDS is therefore part of a nationwide VAT Sensitization Campaign which aims at increasing compliance with VAT legislation. To participate in the VLDS, consumers have to send the details of their VAT Invoice through SMS, the MRA website or the MRA VAT App and they stand a chance of winning up to Rs 50,000 every quarter.

## Who can participate?

Every individual consumer of more than 18 years old and a holder of a VAT Invoice pertaining to purchases for a minimum VAT amount of **Rs 75.\***

\* Every multiple of Rs 75 of VAT amount, the participant will obtain one chance of the VAT Lucky Draw, up to a maximum of 10 chances.

## Draw

Participants will have up to the 15<sup>th</sup> of the month following the end of each quarter to send the details of their VAT invoices for the VAT Lucky Draw Scheme.

The draws will be effected under the supervision of the Gambling Regulatory Authority (GRA) during the last week of the month following the end of every quarter.

## 1. Website

Under '**Participants Details**' kindly fill in the following:

- Full Name
- Telephone / Mobile Number
- Email Address (if any)

Under '**VAT Receipts Details**' kindly fill in the following as per your VAT Invoice :

- VAT No. of Supplier
- VAT Paid
- Date of VAT Invoice
- VAT Invoice Number

Click on '**Submit**' after completing the fields.

Upon submission, if the above details have been correctly entered you will obtain an acknowledgement message and an Email notification on your email address.



## 2. SMS

SMS should be sent on **52 52 82 82**.

SMS cost is at normal rate.

**Message Format:**

**Vat rxxxxxxx ixxxxxx axxxxx dxx-xx-xx**

**xxxxxxx**, is the **VAT Registration Number**;

**xxxxxx** is the **VAT Invoice Number**;

**xxxxxx** is the **VAT amount paid** and;

**dxx-xx-xx** is the **Date of the VAT Invoice** (dd-mm-yy).

In case of wrong format, you will receive an error message on your mobile.
