## CONDITIONS TO BID

1. The MRA Sale by Public Tender will be open to all members of the public over the age of 18.
2. Prospective bidders may view the vehicles on **Thursday 12, Friday 13, Wednesday 18 and Thursday 19 June 2025 from 1000 hours to 1500 hours** at the **Mauritius Revenue Authority, Arcades Cliderlex, Port Mathurin.**
3. The closing date and time for submission of bids is **26 June 2025 at latest by 1400 hours.**
4. **The sale is on an 'AS IS WHERE IS' basis.**
5. Offers shall be open and remain valid for acceptance for a period of 30 days with effect from the closing date.
6. Bidding form together with an office cheque of **at least 10% of the tender offer drawn in favour of the Director-General MRA, shall be clearly marked "MRA/FAD/MVROD202501": SALE BY TENDER OF MOTOR VEHICLES"** and deposited in the **RRA Tender Box, situated at the RRA Central Administration Building, Port Mathurin, Rodrigues.** Bids with personal cheques will be rejected.
7. Deposits will be returned to the bidder if not awarded and forfeited if awarded bidder does not make payment and take delivery by the specified deadline.
8. Successful bidders shall effect payment and take delivery of **ALL ITEMS AWARDED** by **30 June 2025**, failing which the offer will lapse. Payment can only be made either in cash or through an Office Cheque issued by a local bank, drawn in favour of the **'Director-General, MRA'**.
9. The MRA reserves the right:
  - a) To accept or reject any bid, or
  - b) To annul the bidding process and reject all bids at any time prior to the award of the tender without thereby incurring any liability or any obligation to inform any bidder of the grounds for accepting or rejecting any bid.
