



NOTICE TO DECLARANTS/IMPORTERS

DECLARANTS AND IMPORTERS ARE HEREBY INFORMED THAT THE FOLLOWING BUDGETARY MEASURES WILL TAKE EFFECT AS FROM 01 JULY 2015 -

- (i) RATE OF CUSTOMS DUTY ON IRON BARS CLASSIFIABLE UNDER HS CODES 7213.102 AND 7214.202 IS REDUCED FROM 15% TO 10%;**
 - (ii) MID LEVY OF 30 CENTS PER LITRE SHALL NO LONGER BE APPLICABLE ON AVIATION SPIRITS CLASSIFIABLE UNDER HS CODES 2710.1911, 2710.192 AND 2710.1931.**
 - (iii) NO MID LEVY SHALL BE APPLICABLE ON PRODUCTS OF HEADINGS 27.01, 27.10 AND 27.11 MEANT FOR BUNKERING, TRANSIT, RE-EXPORT OR ANY CUSTOMS PROCEDURE OTHER THAN FOR HOME CONSUMPTION.**
- (a) CPC 7007L WILL BE DE-ACTIVATED ON A DATE WHICH WILL BE COMMUNICATED IN DUE COURSE.**
