- (i) Hotel
- (ii) Guest house or tourist residence
- (iii) Enterprise engaged in stone crushing or in the manufacture or processing of aggregates, concrete blocks, pre-casts units, coral sand, rock sand or basalt sand
- (iv) Enterprise engaged in the manufacture, assembly or importation of mobile phones, batteries for vehicles and pneumatic tyres
