

NOTICE TO ECONOMIC OPERATORS

CUSTOMS PROCEDURE CODES - TRADE UNION FEDERATION AND IMPORTED MATURED RUM OR IMPORTED MATURED AGRICULTURAL RUM UNDERGOING FURTHER MATURATION IN MAURITIUS

ECONOMIC OPERATORS ARE HEREBY INFORMED OF THE FOLLOWING MEASURES -

(1) EXCISE DUTY CONCESSION ON MOTOR CARS TO A TRADE UNION FEDERATION

(a) Sub-part A of Part IA of the First Schedule to the Excise Act has been amended by deleting item 24 and replacing it by the following item –
