NOTICE TO ECONOMIC OPERATORS

IMPLEMENTATION OF NEW CUSTOMS ACCESS PASS AS FROM 01 JUNE 2022

1. ECONOMIC OPERATORS ARE HEREBY INFORMED THAT AS FROM **01 JUNE 2022** MRA CUSTOMS IS REPLACING THE EXISTING CUSTOMS ACCESS PASS (CAP) BY A NEWLY DESIGNED CAP FOR CUSTOMS HOUSE BROKERS AND CUSTOMS CLERKS.

2. ALL CUSTOMS HOUSE BROKERS ARE HEREBY REQUESTED TO CALL AT THE REGISTRATION UNIT FOR THE ISSUANCE OF THE NEW CAP. THE FEES OF RS 300 SHALL BE LEVIED FOR THE ISSUANCE OF THE NEW CAP IN ACCORDANCE WITH THE EIGHTH SCHEDULE OF REGULATION 8A OF THE CUSTOMS REGULATIONS 1989.

3. ALL CUSTOMS CLERKS, IMPORTERS, EXPORTERS AND AGENTS ARE HEREBY REQUESTED TO CALL AT THE REGISTRATION UNIT FOR THE ISSUANCE OF THE NEW CAP. THE FEES OF RS 400 SHALL BE LEVIED FOR THE RENEWAL OF THE NEW CAP IN ACCORDANCE WITH THE EIGHTH SCHEDULE OF REGULATION 8A OF THE CUSTOMS REGULATIONS 1989.

4. ALL CUSTOMS CLERKS, IMPORTERS, EXPORTERS AND AGENTS REFERRED UNDER PARAGRAPH 3 SHOULD PROVIDE:-

- (A) DULY FILLED APPLICATION FORM **MRA/CUS/TFCC/REG/ EO 11** AVAILABLE ON THE MRA WEBSITE ON THE FOLLOWING LINK:

- (B) VALID CERTIFICATE OF CHARACTER (NOT OLDER THAN 3 MONTHS).

5. AS FROM 1 SEPTEMBER 2022, ONLY THE HOLDER OF NEW CAP SHALL BE AUTHORISED TO TRANSACT BUSINESS AT CUSTOMS, THUS ALL CUSTOMS BROKERS, CUSTOMS CLERKS, IMPORTERS, EXPORTERS AND AGENTS ARE HEREBY REQUESTED TO CHANGE THEIR EXISTING CAP BY **31 AUGUST 2022**.
