

**NOTICE TO ECONOMIC OPERATORS** 

## AUTHORISATION TO AN OPERATOR OF A LOUNGE AT THE SSR INTERNATIONAL AIRPORT TO MAKE CUSTOMS DUTY, EXCISE DUTY AND VAT FREE PURCHASES OF SPIRITS, WINE, ALE OR BEER TO BE SERVED TO PASSENGERS IN THE LOUNGE

- (1) ECONOMIC OPERATORS ARE HEREBY INFORMED THAT AN OPERATOR OF A LOUNGE, INCLUDING THE STATE LOUNGE, AT THE SSR INTERNATIONAL AIRPORT, SHALL BE ENTITLED TO EXEMPTION OF DUTY, EXCISE DUTY AND TAXES, AS THE CASE MAY BE, ON THE PURCHASE OF SPIRITS, WINE, ALE OR BEER FROM A CUSTOMS-APPROVED STOREROOM, A BONDED WAREHOUSE, A DUTY-FREE SHOP, A SHOP OPERATING UNDER THE DEFERRED DUTY AND TAX SCHEME, A FREEPORT OPERATOR OR A LOCAL MANUFACTURER OF EXCISABLE GOODS, PROVIDED THAT –
  - (a) THE SPIRITS, WINE, ALE OR BEER ARE <u>SERVED TO PASSENGERS</u> IN THE LOUNGE; AND
  - (b) UNDER SUCH TERMS AND CONDITIONS AS THE DIRECTOR-GENERAL MAY DETERMINE.

THIS MEASURE SHALL COME INTO OPERATION ON **15 SEPTEMBER 2022**.

- (2) FOR THE PROPER IMPLEMENTATION OF THE ABOVE MEASURE
  - (a) THE OPERATOR OF THE LOUNGE SHALL BE REGISTERED AT CUSTOMS IN ORDER TO BENEFIT THE EXEMPTION AS "CONSIGNEE";
  - (b) ALL ECONOMIC OPERATORS SPECIFIED IN PARAGRAPH (1) SHALL MAKE BILL OF ENTRY FOR THE REMOVAL / TRANSFER, AS THE CASE MAY BE, OF SPIRITS, WINE, ALE OR BEER TO THE LOUNGE ("CONSIGNEE").
  - (c) THE BILL OF ENTRY BY THE CONCERNED ECONOMIC OPERATORS UNDER PARAGRAPH (1) SHALL BE -
    - (I) ACCOMPANIED BY DULY FILLED FORM: MRA/CUS/GEN/FORM23; AND
    - (II) MADE UNDER THE CUSTOMS PROCEDURE CODES (CPCs) CREATED AS PER TABLE BELOW –
