

NOTICE TO ECONOMIC OPERATORS RELATING TO PROOF OF ORIGIN (Certificate of Origin) UNDER INTERIM ECONOMIC

PARTNERSHIP AGREEMENT BETWEEN THE ESA - EC

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT ARTICLE 18 RELATING TO PROOF OF ORIGIN (Certificate of Origin) OF PROTOCOL 1 OF THE INTERIM ECONOMIC PARTNERSHIP AGREEMENT (iEPA) HAS BEEN AMENDED WHEREBY:

- (A) ORIGINATING GOODS EXPORTED FROM EUROPEAN COMMUNITY AND ITS MEMBER STATES ON OR BEFORE <u>31 AUGUST 2020</u> SHALL BENEFIT PREFERENTIAL MARKET ACCESS IN MAURITIUS ON PRODUCTION OF EITHER:
 - (I) MOVEMENT CERTIFICATES EUR.1; OR
 - (II) AN INVOICE DECLARATION MADE OUT BY AN APPROVED EXPORTER AS PER PROTOCOL 1 TO THE iEPA; OR
 - (III) AN INVOICE DECLARATION MADE OUT BY ANY EXPORTER FOR ANY CONSIGNMENT WHOSE TOTAL VALUE DOES NOT EXCEED EUR
 6,000.
- (B) ORIGINATING GOODS EXPORTED FROM EUROPEAN COMMUNITY AND ITS MEMBER STATES AS FROM <u>01 SEPTEMBER 2020</u> SHALL BENEFIT PREFERENTIAL MARKET ACCESS IN MAURITIUS ON PRODUCTION OF EITHER:
 - (I) INVOICE DECLARATION OF ANY VALUE MADE OUT BY APPROVED EXPORTERS DULY REGISTERED IN THE EU SYSTEM FOR REGISTERED EXPORTERS (REX SYSTEM); OR
 - (II) INVOICE DECLARATION MADE OUT BY ANY EXPORTER FOR ANY CONSIGNMENT WHOSE TOTAL VALUE DOES NOT EXCEED **EUR** 6,000.

English Language:

"The exporter of the products covered by this document (Customs Authorisation No.. *) declares that, except where otherwise clearly indicated, these products are of preferential origin."

French Language:

"L'exportateur des produits couverts par le présent document (authorisation Douanière No.. *) déclare que sauf indication du contraire, ces produits ont l'origine préférentielle....)"

*may be left blank when Exporter is not registered as per REX System of the EU, for consignment value not exceeding 6,000 Euros.

4. THE INVOICE DECLARATION SHALL BEAR THE ORIGINAL SIGNATURE OF THE EXPORTER IN MANUSCRIPT AND BE SUBMITTED AS SUPPORTING DOCUMENT WITH IMPORT CUSTOMS DECLARATION, THROUGH TRADE NET.
