

NOTICE TO ECONOMIC OPERATORS

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT FOLLOWING THE PRESENTATION OF **THE 2020-2021 BUDGET** BY DR THE HONOURABLE MINISTER OF FINANCE, ECONOMIC PLANNING AND DEVELOPMENT ON **4**TH **JUNE 2020**, THE FOLLOWING MEASURES WILL BE IMPLEMENTED **AS FROM 5**TH **JUNE 2020** –

(1) SALE OF GOODS BY DUTY-FREE SHOPS (DFS) AND SHOPS OPERATING UNDER THE DEFERRED DUTY AND TAX SCHEME (DDTS)

- (a) DDTS SHALL BE AUTHORISED TO SELL GOODS TO -
 - (i) VISITORS;
 - (ii) DEPARTING CITIZENS OF MAURITIUS:
 - (iii) MASTERS OR CREWS OF SHIPS OR AIRCRAFTS LEAVING FOR FOREIGN PORTS OR AIRPORTS;
 - (iv) DIPLOMATIC AGENT; AND
 - (v) ANY PERSON <u>WITHOUT ANY RESTRICTION ON THE QUANTITY</u> UPON PAYMENT OF DUTY, EXCISE DUTY OR TAXES.

FOR THE PURPOSE OF PARAGRAPH (a)(v), THE DEFINITION OF "MAINLY" IN REGULATION 90(18) OF THE CUSTOMS REGULATIONS 1989 IS BEING SUSPENDED FOR THE PERIOD STARTING ON 5 JUNE 2020 AND ENDING ON 31 DECEMBER 2021.

- (b) DFS SHALL BE AUTHORISED TO SELL GOODS -
 - (i) FREE OF DUTY, EXCISE DUTY OR TAXES TO
 - (A) A PASSENGER LEAVING FOR, OR ARRIVING FROM, A FOREIGN PORT OR AN AIRPORT;
 - (B) A MASTER OR MEMBER OF A CREW LEAVING FOR A FOREIGN PORT OR AN AIRPORT;
 - (C) ANOTHER DUTY-FREE SHOP:
 - (D) A SHOP UNDER THE DEFERRED DUTY AND TAX SCHEME; OR
 - (ii) TO ANY PERSON <u>WITHOUT ANY RESTRICTION ON THE QUANTITY</u> UPON PAYMENT OF DUTY, EXCISE DUTY OR TAXES.

PARAGRAPH (b)(ii) SHALL BE VALID FOR <u>THE PERIOD STARTING ON 5 JUNE 2020 AND ENDING ON 31 DECEMBER 2021</u>.

(2) <u>CUSTOMS DUTY CONCESSION ON BUSES AND EXCISE DUTY</u> <u>CONCESSION ON MOTOR VEHICLES</u>

(a) AS FROM 5TH JUNE 2020, NEW CONCESSIONS HAVE BEEN PROVIDED FOR:

CUSTOMS DUTY CONCESSION ON BUS

<u>BUS.</u> AS PER ITEM B1 OF SUB-PART B OF PART IIA OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT.

EXCISE DUTY CONCESSION ON MOTOR VEHICLE

- (i) MOTOR CAR WITH AN ENGINE CAPACITY NOT EXCEEDING 1,000 C.C., AS PER ITEM 1 OF SUB-PART B OF PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT:
- (ii) (A) MOTOR CAR WITH AN ENGINE CAPACITY EXCEEDING 1,000 C.C. BUT NOT EXCEEDING 1,600 C.C.;
 - (B) DOUBLE SPACE CABIN VEHICLE;
 - (C) SINGLE SPACE CABIN VEHICLE;
 - (D) THE ELECTRIC VEHICLE; OR
 - (E) VAN,

AS PER ITEM 2 OF SUB-PART B OF PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT.

THE AMENDMENTS MADE TO THE CUSTOMS TARIFF ACT AND EXCISE ACT TO CATER FOR THE CONCESSIONS ARE AS PER <u>ANNEX 1</u>.

- (b) FOR THE PROPER IMPLEMENTATION OF
 - (i) ITEM B1 OF SUB-PART B OF PART IIA OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT; AND
 - (ii) ITEMS 1 AND 2 OF SUB-PART B OF PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT,
