

NEW CUSTOMS PROCEDURE CODES (CPCs) FOR CONSIGNMENTS IMPORTED WHEREBY GOODS ARE SHORT- SHIPPED OR SHORT-LANDED

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT NEW CUSTOMS PROCEDURE CODES (CPCs), AS PER TABLE BELOW, ARE BEING CREATED WHEREBY THE OWNER OF THE GOODS IS AWARE THAT GOODS IMPORTED IN THE CONSIGNMENT HAVE BEEN SHORT-SHIPED OR SHORT-LANDED, FOLLOWING WHICH "WHEREAS" PROCEDURE WILL FOLLOW –

S/N	CPC	DESCRIPTION
1	70FWS	WAREHOUSING OF GOODS FROM DIRECT IMPORT WHEREBY GOODS ARE SHORT-SHIPED OR SHORT-LANDED ("WHEREAS" PROCEDURE TO FOLLOW)
2	98FWS	DIRECT IMPORT INTO FREEPORT OF GOODS WHEREBY GOODS ARE SHORT-SHIPED OR SHORT-LANDED ("WHEREAS" PROCEDURE TO FOLLOW)
3	40FWS	DIRECT IMPORT OF GOODS WHEREBY GOODS ARE SHORT-SHIPED OR SHORT-LANDED ("WHEREAS" PROCEDURE TO FOLLOW) – DET PAYABLE ON WHOLE CONSIGNMENT
4	50FWS	TEMPORARY IMPORT OF GOODS WHEREBY GOODS ARE SHORT-SHIPED OR SHORT-LANDED ("WHEREAS" PROCEDURE TO FOLLOW)

THE ABOVE-MENTIONED CPCs SHALL BE EFFECTIVE AS FROM 7th June 2022.

DECLARANTS ARE HEREBY INFORMED TO-

- (A) INSERT THE BILL OF ENTRY NUMBER MADE UNDER ONE OF THE ABOVE CPCs, IN BOX 43 ("PREVIOUS DECLARATION") WHILE MAKING THE "WHEREAS" BILL OF ENTRY ;
- (B) INSERT THE BILL OF ENTRY NUMBER MADE UNDER ONE OF THE ABOVE CPCs, IN BOX 43 ("PREVIOUS DECLARATION") WHILE MAKING THE "WHEREAS" BILL OF ENTRY TOGETHER WITH THE "PREVIOUS" "WHEREAS" BILL(S) OF ENTRY IN BOX 25 ("MARKS AND NUMBERS") IN CASE THERE ARE MORE THAN ONE "WHEREAS" BILL OF ENTRY.
