## **CONCESSIONS ON MOTOR VEHICLES**

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT <u>AS FROM 5 APRIL 2021</u>, THE UNDER-MENTIONED NEW CONCESSIONS ON MOTOR VEHICLES WILL BE IMPLEMENTED:

1. (a) <u>CUSTOMS DUTY CONCESSION ON BUS</u>

**<u>BUS</u>**, AS PER ITEM B2 OF SUB-PART B OF PART IIA OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT.

- (b) <u>EXCISE DUTY CONCESSION ON MOTOR VEHICLE</u>
  - (i) MOTOR CAR, INCLUDING ONE HAVING BOTH INTERNAL COMBUSTION ENGINE AND ELECTRIC MOTOR, WITH AN ENGINE CAPACITY <u>NOT</u> <u>EXCEEDING 1,000 C.C.</u>, AS PER ITEM 3 OF SUB-PART B OF PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT;
  - (ii) (A) <u>**THE MOTOR CAR</u>**, INCLUDING ONE HAVING BOTH INTERNAL COMBUSTION ENGINE AND ELECTRIC MOTOR, WITH AN ENGINE CAPACITY <u>**EXCEEDING 1,000 C.C.**</u>;</u>
    - (B) DOUBLE SPACE CABIN VEHICLE;
    - (C) SINGLE SPACE CABIN VEHICLE;
    - (D) THE ELECTRIC VEHICLE; OR
    - (E) VAN,

AS PER ITEM 4 OF SUB-PART B OF PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT.
