NOTICE TO ECONOMIC OPERATORS

CONCESSIONS ON MOTOR VEHICLES

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT FURTHER TO THE GAZETTING OF THE *CUSTOMS TARIFF (AMENDMENT OF SCHEDULE) (NO. 4) REGULATIONS 2021 (G.N NO. 134 OF 2021)* AND *EXCISE (AMENDMENT OF SCHEDULE) (NO.4) REGULATIONS 2021 (G.N. NO. 135 OF 2021)*, THE UNDER-MENTIONED NEW CONCESSIONS ON MOTOR VEHICLES WILL BE IMPLEMENTED <u>AS FROM 1 JULY 2021</u>:

1. (a) <u>CUSTOMS DUTY CONCESSION ON BUS</u>

<u>BUS</u>, AS PER ITEM B2 OF SUB-PART B OF PART IIA OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT.

- (b) <u>EXCISE DUTY CONCESSION ON MOTOR VEHICLE</u>
 - (i) MOTOR CAR, INCLUDING ONE HAVING BOTH INTERNAL COMBUSTION ENGINE AND ELECTRIC MOTOR, WITH AN ENGINE CAPACITY <u>NOT</u> EXCEEDING 1,000 C.C., AS PER ITEM 3 OF SUB-PART B OF PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT;
 - (ii) (A) <u>THE MOTOR CAR</u>, INCLUDING ONE HAVING BOTH INTERNAL COMBUSTION ENGINE AND ELECTRIC MOTOR, WITH AN ENGINE CAPACITY <u>EXCEEDING 1,000 C.C.</u>;
 - (B) DOUBLE SPACE CABIN VEHICLE;

- (C) SINGLE SPACE CABIN VEHICLE;
- (D) THE ELECTRIC VEHICLE; OR
- (E) VAN,

AS PER ITEM 4 OF SUB-PART B OF PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT.

2. THE AMENDMENTS MADE TO THE CUSTOMS TARIFF ACT AND EXCISE ACT TO CATER FOR THE CONCESSIONS ARE AS PER <u>ANNEX I</u>.

- 3. FOR THE PROPER IMPLEMENTATION OF THE ABOVE MEASURES
 - (I) <u>CPCS 40CB2, 47CB2 AND 49CB2</u> SHALL BE USED FOR THE PROCESSING OF BILLS OF ENTRY FOR THE CLEARANCE OF BUSES UNDER ITEM B2 OF SUB-PART B OF PART IIA OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT; AND
 - (II) <u>CPCS 40EB3, 47EB3, 49EB3, 40EB4, 47EB4 AND 49EB4</u> SHALL BE USED FOR THE PROCESSING OF BILLS OF ENTRY FOR THE CLEARANCE OF MOTOR VEHICLES UNDER ITEMS 3 AND 4 OF SUB-PART B OF PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT.

THE ABOVE MEASURES SHALL COME INTO OPERATION ON <u>1ST JULY 2021 AND SHALL</u> <u>BE VALID UP TO 30TH JUNE 2022.</u>
