NOTICE TO ECONOMIC OPERATORS

IMPLEMENTATION OF AMENDMENTS TO CUSTOMS LAWS

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT -

- (1) REGULATIONS 3(a)(iii) and (iv) OF THE CUSTOMS TARIFF (AMENDMENT OF SCHEDULE) (NO.5) REGULATIONS 2021 (G.N. NO. 212 OF 2021) HAVE AMENDED PART I OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT
 - (A) BY DELETING H.S. CODES 8702.40.91 AND 8702.40.99 AND THEIR CORRESPONDING ENTRIES;
 - (B) BY INSERTING, IN THE APPROPRIATE NUMERICAL ORDER, THE H.S. CODES AND THEIR CORRESPONDING ENTRIES SET OUT IN **ANNEX I**;

KINDLY NOTE THAT **ANNEX I** IS IN THE FORMAT OF THE INTEGRATED TARIFF.

THIS MEASURE SHALL COME INTO OPERATION ON <u>15 SEPTEMBER</u> <u>2021.</u>

(2) REGULATION 3 OF THE EXCISE (AMENDMENT OF SCHEDULE) (NO.6) REGULATIONS 2021 (G.N. NO. 232 OF 2021) HAS AMENDED SUB-PART A OF PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT BY DELETING ITEM 8 AND ITS CORRESPONDING ENTRIES AND REPLACING IT BY NEW ITEM 8 AND ITS CORRESPONDING ENTRIES SET OUT IN ANNNEX II.

FOR THE PROPER IMPLEMENATION OF THIS MEASURE -

(A) CUSTOMS PROCEDURE CODES (CPCS), 40X08, 47X08 AND 70X08, SHALL BE AMENDED AS PER TABLE 1 BELOW:
