

NOTICE TO ECONOMIC OPERATORS

Amendments to Part I of the First Schedule to the Customs Tariff Act and Part IV of the First Schedule to the Excise Act— Electrical appliances

A. AMENDMENTS TO CUSTOMS LAWS

- (1) ECONOMIC OPERATORS ARE HEREBY INFORMED OF THE FOLLOWING REGULATIONS -
 - (A) THE CUSTOMS TARIFF (AMENDMENT OF SCHEDULE) (NO. 4) REGULATIONS 2022 (G.N. NO. 206 OF 2022); AND
 - (B) THE EXCISE (AMENDMENT OF SCHEDULE)(NO. 3) REGULATIONS 2022 (G.N. NO. 205 OF 2022),

WHICH HAVE RESPECTIVELY AMENDED PART I OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT AND PART IV OF THE FIRST SCHEDULE TO THE EXCISE ACT BY –

- (I) DELETING THE H.S CODES SPECIFIED IN PART I OF ANNEX I;
- (II) INSERTING, IN THE APPROPRIATE NUMERICAL ORDER, THE HS CODES SPECIFIED IN PART II OF **ANNEX I**.

RELATED TO REGULATION 99E OF THE EXCISE REGULATIONS 1994.

KINDLY NOTE THAT ANNEX I IS IN THE FORMAT OF THE INTEGRATED TARIFF.

COPIES OF THE ABOVE-MENTIONED REGULATIONS ARE ANNEXED.

- (2) THE ABOVE AMENDMENTS CATER FOR THE FOLLOWING
 - (A) (I) THRESHOLD OF ENERGY EFFICIENCY INDEX FOR REFRIGERATORS AND DISHWASHERS HAS BEEN AMENDED TO DIFFERENTIATE BETWEEN EFFICIENT AND INEFFICIENT ELECTRICAL APPLIANCES; AND
 - (II) REFRIGERATORS AND DISHWASHERS ABOVE THE THRESHOLD SHALL BE CONSIDERED AS INEFFICIENT ELECTRICAL APPLIANCES, WHEREBY THE 25% LEVY(EXCISE DUTY) SHALL APPLY;

(B) WASHING MACHINES HAVE BEEN REMOVED FROM THE SCOPE OF THIS MEASURE

THE ABOVE MEASURES SHALL COME INTO OPERATION ON 1 SEPTEMBER 2022.

- (3) (A) KINDLY NOTE THAT AS PER REGULATION 4 OF G.N. NO. 205 OF 2022, "the rate of levy (excise duty) applicable on goods of H.S. Codes 8418.10.10, 8418.21.10, 8418.29.10 and 8422.11.10, prior to 1 September 2022, shall continue to apply, provided that
 - (a) the goods were in bonded warehouse on or before 31 August 2022; and
 - (b) the importer of the goods submits a certificate of conformity from the manufacturer of the goods, or from an <u>accredited institution</u>, certifying that the goods are in accordance with MS 201:2012 or MS 205:2011, as the case may be."
 - (B) FOR THE PROPER IMPLEMENTATION OF THE MEASURE AT PARAGRAPH (A), NEW CUSTOMS PROCEDURE CODE (CPC) IS BEING CREATED AS PER TABLE 1 BELOW:

FOR THE PURPOSE OF PARAGRAPH (A)(2)(B), ECONOMIC OPERATORS ARE HEREBY INFORMED THAT THE CUSTOMS PROCEDURE CODES (CPCS) 40TOP AND 47TOP, CREATED UNDER DI 2 OF 2017, SHALL NO LONGER BE EFFECTIVE AS FROM 1 SEPTEMBER 2022.
