

NOTICE TO ECONOMIC OPERATORS

IMPLEMENTATION OF THE AFRICAN CONTINENTAL FREE TRADE AREA AGREEMENT (AFCFTA AGREEMENT)

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT -

- (1) THE AfCFTA Agreement SHALL ENTER INTO FORCE AS FROM 1ST JANUARY 2021.
- (2) FOR THE IMPLEMENTATION OF THE AFCFTA AGREEMENT -
 - (A) THE FIRST SCHEDULE OF THE CUSTOMS TARIFF ACT IS BEING AMENDED; AND
 - (B) REGULATIONS RELATED TO EXPORT TO THE AFRICAN CONTINENTAL FREE TRADE AREA ARE BEING INTRODUCED.
- (3) (A) ORIGINATING GOODS EXPORTED FROM A STATE PARTY OF THE AFCFTA AS FROM <u>01 JANUARY 2021</u> SHALL BENEFIT PREFERENTIAL MARKET ACCESS IN MAURITIUS
 - (a) ON PRODUCTION OF EITHER:
 - (I) CERTIFICATE OF ORIGIN AS PER ARTICLE 17 OF THE AGREEMENT; OR
 - (II) AN ORIGIN DECLARATION MADE OUT BY AN APPROVED EXPORTER, AS PER ARTICLE 19 TO THE AGREEMENT; OR
 - (III) AN ORIGIN DECLARATION MADE OUT BY ANY EXPORTER FOR ANY CONSIGNMENT WHOSE TOTAL VALUE DOES NOT EXCEED USD 5,000, AS PER ARTICLE 19 OF THE AGREEMENT.
 - (b) AT THE RATE OF CUSTOMS DUTY SPECIFIED IN THE "AFCFTA" COLUMN OF THE INTEGRATED TARIFF.



- (B) ORIGINATING GOODS EXPORTED FROM THE REPUBLIC OF MAURITIUS AS FROM <u>01 JANUARY 2021</u> SHALL BENEFIT PREFERENTIAL MARKET ACCESS IN A STATE PARTY OF THE AFCFTA
 - (a) ON PRODUCTION OF EITHER:
 - (I) CERTIFICATE OF ORIGIN AS PER APPENDIX I TO ANNEX 2 TO THE PROTOCOL; OR
 - (II) AN ORIGIN DECLARATION MADE OUT BY AN APPROVED EXPORTER, AS PER APPENDIX II TO ANNEX 2 TO THE PROTOCOL; OR
 - (III) AN ORIGIN DECLARATION MADE OUT BY ANY EXPORTER FOR ANY CONSIGNMENT WHOSE TOTAL VALUE DOES NOT EXCEED USD 5,000, AS PER APPENDIX II TO ANNEX 2 TO THE PROTOCOL.
 - (b) AT THE RATE OF CUSTOMS DUTY SPECIFIED IN ANNEX 1 TO THE AGREEMENT.

APPLICATIONS FOR CERTIFICATE OF ORIGIN HAVE TO BE MADE ELECTRONICALLY ON THE TRADENET.
