## IMPORT AND CLEARANCE OF AIR CONDITIONERS PLACED IN A BONDED WAREHOUSE OR SHIPPED BEFORE 1 SEPTEMBER 2025

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT CUSTOMS PROCEDURE CODES (CPCs) HAVE BEEN CREATED AS PER TABLE BELOW, FOR THE PROPER IMPLEMENTATION OF THE ENERGY EFFICIENCY (MINIMUM ENERGY PERFORMANCE STANDARDS FOR REGULATED MACHINERY) REGULATIONS 2025 (GN NO. 45 OF 2025), ADMINISTERED BY THE ENERGY EFFICIENCY MANAGEMENT OFFICE (EEMO), WITH RESPECT TO THE IMPORT AND CLEARANCE OF AIR CONDITIONERS PLACED IN A BONDED WAREHOUSE OR SHIPPED BEFORE 1 SEPTEMBER 2025 —
