

NOTICE TO ECONOMIC OPERATORS

CONTRIBUTIONS ON PETROLEUM PRODUCTS (MOGAS AND GASOIL)

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT -

- (1) AS FROM 3 OCTOBER 2022, THE CONTRIBUTIONS TO -
 - (a) THE ROAD DEVELOPMENT AUTHORITY (ITEM 1 OF THE FOURTH SCHEDULE TO THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT); AND
 - (b) THE RODRIGUES TRANSPORTATION AND STORAGE (ITEM 2 OF THE FOURTH SCHEDULE TO THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT),
 - LEVIED ON PETROLEUM PRODUCTS (MOGAS AND GAS OIL), SHALL BE PAID BY THE STATE TRADING CORPORATION (STC) TO THE DIRECTOR-GENERAL.
- (2) (a) THE CONTRIBUTIONS REFERRED TO IN PARAGRAPH (1) SHALL BE LEVIED ON A PETROLEUM PRODUCT AT THE RATES SPECIFIED IN **ANNEX I**.
