



Award of Procurement Contract

Notice under section 40(7) of the Public Procurement Act

This is to notify that, following the bidding exercise carried out by the Mauritius Revenue Authority for the Provision of Transport Services (MRA/OABTRANSPORT/63/25), the contract has been awarded to Travel Desire Coach Ltd of Royal Road, La Rosa as follows:

- (i) **Door to door conveyance of staff (Customs Officers) in 14 seater vans** to and from any location/s throughout the island from and to SSR International Airport (Arrival/Departure Halls and Cargo Shed) for Rs. 1,111.40 per trip.
- (ii) **Conveyance of staff between 0600 to 1800 hours in 14 seater vans:**
 - a. from MRA premises including SSRIA to any location throughout the island on a drop only basis for Rs. 1,305.70 per trip; and
 - b. from any location throughout the island to MRA premises including SSRIA on a drop only basis for Rs. 917.10 per trip.
- (iii) **Conveyance of staff on site visits from any MRA premises to and from any location throughout the island and back on a drop, wait and return basis in 14 seater vans:**
 - a. first four hours for Rs. 1,694.30 per trip; and

 - a. Ehram Court, Belfort Tower, Custom House - to move within Port-Louis for Rs. 1,888.60 per day; and
 - b. ICCC – to move to Port Louis and back twice per week and within the airport/cargo shed region up to Mahebourg and Plaine-Magnien for Rs. 3,054.41 per day.

Provision of Transport Services - Letter of Acceptance

- b. from any location throughout the island to any location throughout the island on a drop only basis for Rs. 1,888.60 per trip.

(vi) Conveyance of Staff to and from Victoria Bus Terminal (Gare du Sud) – Port Louis to and from Custom House – Mer Rouge, Port-Louis in 56 Seater Bus for Rs 2,277.20 per trip.

3. The contract shall be for a period of two years starting 01 July 2025 to 30 June 2027, renewable on an annual basis subject to satisfactory performance. Also, as per clause 6.6 of the General Conditions of Contract contained in the bidding documents, the rates shall be adjusted for any increase or decrease in fuel prices following reviews conducted by the STC through the Petroleum Pricing Committee. The weight of the fuel component in the quoted rate is 40%.
4. You are requested to furnish, as per the Conditions of Contract, a Performance Security in the form of a Bank Guarantee for an amount of Rs. 500,000.00 within 28 days from the date of this Letter of Acceptance. You should use for that purpose the template for Performance Security as per the bidding documents. The Performance Security shall expire on 28 July 2027.
5. Kindly note that in the absence of a formal agreement, this letter of acceptance together with all the documents and conditions related to this bidding exercise shall constitute a binding contract between the MRA and Travel Desire Coach Ltd.
6. You are also requested to attend a meeting on Thursday 29 May 2025 at 1300 hours, Level 8 Eham Court to discuss matters related to the execution of this contract.
