

NOTICE TO ECONOMIC OPERATORS

SECOND-HAND MOTOR VEHICLE IMPORTED FOR RALLY PURPOSES

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT FOR THE PROPER IMPLEMENTATION OF THE CONSUMER PROTECTION (CONTROL OF IMPORTS) (AMENDMENT NO. 3) REGULATIONS 2023 (**G.N. No. 99 of 2023**), WITH RESPECT TO "A SECOND-HAND MOTOR VEHICLE, INCLUDING A LEFT-HAND DRIVE SECOND-HAND MOTOR VEHICLE, **WHICH IS IMPORTED FOR RALLY PURPOSES**":-

(1) CUSTOMS PROCEDURE CODES (CPCs) HAVE BEEN CREATED, AS PER TABLE BELOW -

- (2) (I) THE SECOND-HAND MOTOR VEHICLE UNDER THIS MEASURE SHALL BE ADMINISTRATED UNDER SECTION 21 OF THE CUSTOMS ACT.
 - (II) THE BILL OF ENTRY AT IMPORT MADE UNDER CPC 50MVR SHALL BE ACCOMPANIED BY THE SPECIFIED DOCUMENTS TOGETHER WITH A SCANNED COPY OF THE ORIGINAL DOCUMENTS ISSUED BY NLTA IN RELATION TO THE
 - (A) RESTRICTED PERIOD FOR THE IMPORTATION OF THE SECOND-HAND MOTOR VEHICLE; AND
 - (B) THE **VISITOR'S LICENCE** FOR THE IMPORTATION OF THE SECOND-HAND MOTOR VEHICLE
 - (III) THE IMPORTER SHALL ALSO FURNISH AN ADEQUATE SECURITY TO COVER THE DUTY, EXCISE DUTY AND TAXES WHICH WOULD OTHERWISE BE PAYABLE.
