

NOTICE TO DECLARANTS/IMPORTERS/LOCAL MANUFACTURERS

DECLARANTS, IMPORTERS AND LOCAL MANUFACTURERS ARE HEREBY INFORMED THAT AS PER FINANCE(MISCELLANEOUS PROVISIONS) ACT 2016 EXCISE TAX OF 3 CENTS PER GRAM OF SUGAR CONTENT HAS BEEN EXTENDED TO "SUGAR SWEETENED NON-ALCOHOLIC BEVERAGES" <u>AS FROM 01 OCTOBER 2016</u>.

SUGAR SWEETENED NON-ALCOHOLIC BEVERAGES AS PER THE EXCISE ACT -

- (a) MEANS ANY NON- ALCOHOLIC BEVERAGES CONTAINING SUGAR; AND
- (b) INCLUDES JUICES, MILK-BASED BEVERAGES AND SOFT DRINKS.

TO IMPLEMENT THE ABOVE MEASURE THE CUSTOMS TARIFF ACT/INTEGRATED TARIFF IS AMENDED BY:

- (a) DELETING THE HS CODES 0402.99, 0403.10 AND 0403.90; AND
- (b) INSERTING, IN THE APPROPRIATE NUMERICAL ORDER, THE HS CODES AND THEIR CORRESPONDING ENTRIES SPECIFIED IN ANNEX 1.
