

#### MRA collects 1816 pints of blood

The Mauritius Revenue Authority (MRA), remitted 1816 pints of blood to the Blood Transfusion Service during the MRA Blood Donation 2024.



The MRA Blood Donation was officially launched by Dr. Poonam Gungadin, Director Health Services, Ministry Of Health and Wellness on Wednesday, July 17<sup>th</sup>, 2024, in the presence of Mr. Dhanraj Ramdin, Acting Director-General of MRA, MRA Board members, MRA Management Team, Senior Officials from the Ministry, MRA personnel and blood donors.

For this year's Blood Donation, 1140 pints were collected on Wednesday, July 17<sup>th</sup>, 2024, at three MRA locations in Port-Louis, the Custom House, Mer Rouge, Ehram Court, and Belfort Tower.

On Friday, July 19<sup>th</sup>, 2024, 676 pints were collected at the Integrated Customs Clearance Centre (ICCC), Le Chaland, Plaine Magnien and the SSR International Airport, Plaisance.





Dr. Gungadin, the chief guest, delivered a keynote address in which she extended her gratitude to MRA, one of the best blood donation organizers, for its sustained commitment to hosting the annual event. She praised MRA's tireless efforts in facilitating blood donations, which she deemed essential to maintaining the stability of blood stock levels at the National Blood Transfusion Service (NBTS).

According to Dr. Gungadin, these donations play a vital role in providing support to patients suffering from life-threatening illnesses, and facing medical emergencies in hospitals. For instance, donated blood helps patients who require transfusions during surgery.





Service to Man is Service to God. Mr. Dhanraj Ramdin, the Acting Director-General at the Mauritius Revenue Authority (MRA), highlighted this noble saying in his address. He emphasized that MRA's dedication to corporate social responsibility has been a hallmark of its operations, with a strong focus on giving back to the community.

A dedicated team of MRA Officers spearheaded the project, with external stakeholders actively participating in this noble endeavor.



On this score, Mr. Ramdin praised the MRA team for their efforts in organizing these blood donation drives, which have not only brought together employees from various departments but also engaged with local communities and stakeholders. The success of these initiatives has not only contributed to the well-being of patients but has also promoted a sense of social responsibility within the organization.

In addition to its blood donation efforts, MRA has also prioritized environmental sustainability and promotion of a Green Mauritius. Since 2007, the organization has distributed over 20,000 plants to encourage a greener environment. Mr. Amick Teeluckdharry, Assistant Director at the Taxpayer Education and Communication Department (TECD), welcomed attendees and emphasized MRA's three-fold activities: revenue collection, implementation of Financial Assistance Schemes, and organising social activity like Blood Donation aimed at intervening in the pressing needs of Mauritian citizens. He concluded by highlighting MRA's
