## ELIGIBILITY CRITERIA AND DOCUMENTS TO BE SUBMITTED TO BENEFIT FROM EXCISE DUTY EXEMPTION ON DOUBLE SPACE CABIN VEHICLE AND SINGLE SPACE CABIN VEHICLE <u>IN</u> <u>RODRIGUES</u>

## (a) General

- (1) The applicant should have been engaged in any business mentioned below for the last 2 years.
- (2) The following documents should be produced (**ORIGINAL + 2 PHOTOCOPIES**)

- (c) In case of a married couple, if both spouses are engaged in any one of the above activities, only one spouse will be eligible to the duty exemption.
- (d) In case the application is made in the name of the heirs of a deceased person, the original and one copy of the affidavit establishing the heirs of the deceased person and of the death certificate should also be submitted.
- (e) In case the applicant has benefitted from duty exemption on a pickup vehicle in the past, he should submit the original and one copy of the horse power certificate of the vehicle.
